### About the A4AI-Nigeria Coalition

The Alliance for Affordable Internet (A4AI) brings together prominent players from the private sector, public sector, and civil society to provide a unified voice and coordinated focus in addressing the shared goal of open, affordable access to the Internet in the developing world. The Alliance aims to increase the affordability of both mobile and fixed-line Internet access dramatically, with a focus on achieving the UN Broadband Commission Broadband Target of entry-level broadband services priced at less than 5% of average monthly income.

At the start of its work in Nigeria, A4AI held a successful [1st A4AI-Nigeria Forum](#) in which a number of priority issues were identified. These priority issues have the potential to undermine efforts to increase Internet access and affordability to broadband in Nigeria. The priority issues identified in Nigeria are:

- Infrastructure Sharing and Open Access
- Spectrum
- Consumer Awareness and Pricing Transparency

The Coalition members have formed three working groups to work on each priority issue. These working groups developed work plans and started developing policy and regulatory outputs (draft proposals, recommendations, etc.) designed to resolve the key challenges.

### Objectives and Outline of the A4AI-Nigeria Coalition Meeting

The A4AI Nigeria Coalition Meeting on Tuesday 24<sup>th</sup> November is open to all stakeholders interested in increasing broadband access and affordability in Nigeria. It will give each of the three A4AI-Nigeria working groups the opportunity to explain the challenges to affordability they are addressing, progress to date and expected outcomes in the near future.
